## Items and actions

#### Welcome and instructions

The Chair welcomed attendees and invited guests to the meeting.



#### **Minutes and Actions**

Minutes and actions from the previous Construction Industry Inquiry Group (CIIG) meeting on 27 August 2020 were approved.

# **Website Upgrade**

It was agreed that the agenda and minutes from actions will be uploaded onto the Fair Work Convention's website.

## Scottish Government (SG) Construction Update

The discussion centred around the following:

- Statutory sick pay especially for self-employed workers who will need to selfisolate due to Coronavirus.
- Restriction of Movement how will this affect workers who have to travel between different regions and nations within the UK.
- There needs to be clearer guidance from the SG around working and travelling if further local lockdowns are put in place.
- Apprenticeships looking at the focus on these, given the amount of expenditure, and if it joins up with the skills agenda.
- The Construction Leadership Forum the CIIG are keen to keep up to date with how the restart and recovery group are progressing.

#### **Procurement**

- Presentation from Jamie Kennedy and John Docherty
- How Does the Fair Work Framework Apply in the Public Sector
- FW Best Practice Guidelines

Transport Scotland presented their procurement practices, focussing on the fair work aspect of the procurement process.

The CIIG heard from procurement colleagues from a variety of organisations, all of whom shared their own practices and experience, focussing on the fair work question. It was noted that:

- although there are processes in each organisation for auditing what the tenderers have stated in their application, this is not a robust system.
- fair work is still not widely understood by organisations and therefore not scored upon in some procurement exercises.
- there is a lack of consistency across the board with regards to the questions being asked, and the weightings of such questions.
- there is no mechanism to ensure that tier 2/3 contractors are also receiving fair work, the correct pay etc.
- there will be a lot of uncertainty in the coming months with Brexit.
