# Presentation from Fergus Murray, Head of Development and Economic Growth at Argyll & Bute Council - Fair Work in Construction in Rural and Island Communities

- Young Peoples employment and apprentices in the construction industry in rural areas and attracting young people to the trade;
- Procurement practice with contractors and sub-contractors;
- The impact of the loss of EU workers and BREXIT;
- · Access to training opportunities in rural areas;
- Gender bias and wages

#### Independent legal advice on procurement
