#### Welcome

Mary started the meeting by welcoming Tracy Gilbert as a new member of the Fair Work Convention. Tracy is the Scottish Regional Secretary for USDAW (the Union of Shop, Distributive and Allied Workers).

Neil McInroy and Julie McLaughlin from Community Wealth Building (CWB) Legislation team of the Scottish Government were also welcomed to the meeting and invited to deliver their presentation.

### **Community Wealth Building legislation**

Neil McInroy and Julie McLaughlin then gave a presentation to members on the Scottish Government's Community Wealth Building legislation. The purpose of this session is to make the Convention aware of the public consultation on Community Wealth Building Bill and to think about the opportunity to embed fair work in the Bill. The Bill could give fair work conditionality a legal status and encourage its use by local government.



There was then a question-and-answer session with Convention members on the Community Wealth Building legislation.

The main topics of discussion were:

- The overlap between fair work and community wealth building
- Strengthening guidance and legislation around procurement
- Devolved employment law moved up the agenda
- The fair work construction inquiry recommendations around procurement and legal advice around procurement
- The fair work Social Care report 2019 and sectorial bargaining, ministerial support but little progress
- Implementing legislation, financial pressures and managing budgets
- Policy leavers and pillars of economic wealth building to drive forward the agenda
- Anchor organisation progress
- Local supply chain and the Just Transition agenda
- Putting money into training the right people and empower them
- Private Sector organisations and how it would benefit them and what would be their role
- The benefits to community and how it will translate to jobs and skills
- Who the key actors are the state and the employer community
- Capacity building is a real challenge particularly in the third sector
- Planning is a key policy leaver at local and national level
- How Community Wealth Building and fair work is linked with NSET
