### Item 2. Presentation from Lewis Hedge on NSET Refresh – People Pillar

Lewis Hedge then made a presentation to members on Scotland's refreshed National Strategy for Economic Transformation (NSET).

His presentation is an opportunity for members to discuss the proposed People pillar, which brings together Skills, Fair Work and Employment.

# Item 3. Presentation - Scottish Government - Economic Inactivity and Employer Engagement

Patricia then welcomed Paul Travers to present on the work the Scottish Government has undertaken to engage with employers on health and work services and flexible working.

The presentation of Labour market participation included:

- Economic Inactivity in Scotland trends higher than rUK, ill health is a key driver
- There is a strong local/regional element to the picture
- Cross-government focus on Employability, Health and workplaces
- We have been asking employers what works and what they need
- Labour market participation: it's a system, and local

The presentation on Economic inactivity included:

- Economic Inactivity is a persistent issue for Scotland.
- Long term sickness is the main reason for being economically inactive in Scotland.
- Inactivity also differs across groups, but long-term sickness is a common issue
- Strong local/regional element to the picture
- The highest prevalence of inactivity is among young people aged 16-24, although it has fallen in recent years following the start of the pandemic.
- Important gender differences in the story and;
- The inactive are much less likely to enter work than the unemployed
